Grants

The decision to apply for this grant was partially based on feedback and recommendations from the professional grant writer I consulted with in January. Right now, we are working on the assumption that we would share that position about 75% TLFPD 25% GGFD. We will be using the grant writer to write this grant so there will be some cost associated with that, I will update the BOD when that cost is finalized.

Stations/Maintenance/Equipment

- We will be removing the old semi-trailer from behind station 83 this Saturday to make room for the water runoff mitigation project.
- The electrical work for the SCBA compressor at station 82 has been awarded, parts have been ordered and waiting on an install date.

- We are going to try Evergreen FD for vehicle maintenance and see how the do with a couple of PM's.
